- Air Quality & Emission Control Consultants indoor air quality, asbestos, lead, mold, radon, industrial emission control, leak detection and repair services (LDAR), etc.
- Ecological Conservation & Restoration groundwater/hydrogeology, natural resource conservation, environmental impact, biological, wildlife studies, etc.
- Environmental Compliance & Permitting Consultants environmental audits and permitting
- Environmental Site Assessment Consultants environmental due-diligence, Phase I/II/III, SWPPP
- Laboratories analysis of contaminated soil, water and air
- Specialty Design Consultants landfills, source separation recycling centers, transfer stations and wastewater treatment plants
- Wetland Consultants consulting services around invasive species, lakes, ponds and wetlands management including mitigation banks (distribute carbon credits to preserved properties, such as forestry/wetland. Used to offset adverse impacts to nearby ecosystems due to developments)
